In the last years, several initiatives were taken in order to harmonise the LCA-based methods for products and organisations. A recent example is the EU environmental footprint initiative “Single Market for Green Products” which aims at enabling a comparison of environmental performances between similar products and companies. In this context methodological guidelines are developed such as PEF, PEFCR, OEF, OEFCR and ENVIFOOD protocol. Which other initiatives aiming at harmonisation of LCA-based methods are currently under development? Are the expectations of the stakeholders met? Is harmonisation of LCA-based methods on track?
